

**1. Eligibility:** The Truth In Nature / Smith & Wesson Giveaway is open only to all natural persons who are legal residents of the 50 United States, who are at least 21 years old at time of entry. Person must be eligible, according to law, to purchase and/or own a firearm in the United States.
